A new internet resource is now on line in South Australia to help communities understand the workings of their local Councils.

Titled *How Councils Work: A Guide to the Rules,* the website aims to encourage participation in Local Government through informed dealings with councils.

It features a wealth of information and links. And to ease any complexity for readers, cartoonist, Ross Bateup has provided a light-hearted approach to the site with ingenious cartoons that explain the operating concepts and machinery of Local Government.

Local Government Minister, Rory McEwen hailed the website as a highly practical community guide. 'Local Government is taking on a growing importance as the third tier of our democratic structures, dealing with a host of matters which affect people and businesses at the local community level.'

How Councils Work: A Guide to the Rules features user-friendly drop-down menus and answers to Frequently Asked Questions. These include links and answers to issues such as:

- What are the roles and responsibilities of Local Government Councils?
- How are Councils accountable to their communities?
- How does the rating systems work?

• What do I do if I want to question a Council decision or action?

Bureau of Transport and Regional Services Inaugural National Regional Research Colloquium 19 February 2004, Canberra

The Bureau of Transport and Regional Economics within the Australian Government Department of Transport and Regional Services is arranging an inaugural national Regional Research Colloquium in Canberra on 19 February 2004. The Colloquium is being held at Olim's Canberra Hotel.

The purpose of the day is to provide a forum for presentation of current or new work from a range of researchers across Australia, addressing the theme of Regional Dimensions in National Development.

The day will begin with keynote addresses from a panel of chosen speakers. A range of papers of no more than 20 minutes duration will follow, with time for questions. The presentations will be published by the Bureau of Transport and Regional Economics. A Colloquium dinner will be held on the evening of 19 February.

Expressions of interest in presenting a paper at the Colloquium are invited. An abstract of the proposed paper, of no more than 500 words, should be emailed to Dr Judith Winternitz, Deputy Executive Director, Bureau of Transport and Regional Economics by 16 January 2004 at <u>judith.winternitz@dotars.gov.au</u>. The proposed papers must address the theme. Authors will be notified of the acceptance of their proposals by 23 January 2004, with a view to providing an electronic version of the full paper to the Bureau by 6 February 2004.

Registration is required to attend the Colloquium by 6 February on the official registration form. Registration covers morning and afternoon tea and lunch. Participants are asked to indicate their intention to attend the dinner and to cover their own dinner costs (maximum \$50).

Please note that following the Colloquium, on 20th February, a policy research forum is being planned by the National Research Network of the Standing Committee on Regional Development (the officials supporting the Commonwealth/State Ministers' Regional Development Council) at the same venue, to bring researchers and policy makers together to discuss research needs in a number of key policy areas.

XI World Congress of Rural Sociology, Trondheim, Norway Globalisation, Risks and Resistance 25-30 July 2004

Call for Abstracts

The theme of the XI World Congress of Rural Sociology is unevenness, risks, resistance and dialogue in relation to rural economies and societies throughout the world. In exploring the role of agency in mediating and negotiating change, congress papers will pay particular attention to the associated processes of social inclusion and exclusion for people in rural areas. Papers will be presented in Working Group and Symposia sessions, which broadly address the following themes:

Rural governance: local partnerships, decentralization and the state, New social movements, Resistance, transformation and challenges, Gender issues in rural societies, New developments in food supply chains. Globalization and the family farm: struggles, strategies and new opportunities, Rural development policy and practice, Resources, territory and environment, Alternative agricultures

The XI World Congress will be held in Trondheim (pronounced Tron-heim): Norway's third largest city with a population of about 150,000. Trondheim is a modern city with a highly respected university and a research community ranking among the best in Europe. It is also a popular stop for tourists pursuing the summer Midnight Sun or the Northern Lights (aurora borealis) of winter.

Abstracts of 250 words for paper or poster presentations that address the conference theme are now being invited.
